Proposed Amendments to the Constitution and Regulations

Jurisprudence Committee moves that Article 21.4.6 of the Constitution be amended by adding the following: Article 21.4.6.1. (New Addition) "The Grand Master on receipt of proof of criminal conviction from a Court of Law shall immediately issue a Notice of suspension or expulsion either temporary or permanent on any member who has been found guilty of criminal offences as listed.

I, RWBro Don MacWilliam move and seconded by RWBro John Pelletier: that the Finance Committee be authorized to draw 5% of the interest earned on the capital investments of the Masonic Higher Education Bursary Fund and the Benevolent Fund, these moneys to be applied to the operations of Grand Lodge, which would reduce or negate the need to increase the per capita.

Innisfail Lodge No. 8

MOTION: Change Article 14 — Voting Powers at District Meetings and the Grand Lodge Annual Communication by allowing all Master Masons a vote.

WHEREAS: Some Master Masons have no desire to ascend to the chair of King Solomon (Worshipful Master)

WHEREAS: Some Master Masons work diligently for the betterment of their Lodge, year after year without holding an office and no desire to hold office. WHEREAS: There is a perception that

the Grand Lodge is divided into two categories — Past Masters; Lodge Officers and Master Masons not holding office.

THEREFORE: Jurisprudence Committee having examined the Innisfail Lodge No. 8 resolution and after careful examination recommend that Article 14 requires no change and in order to meet the intent of the Innisfail Lodge motion the only required change needed is to the Constitution definition of C.0.19 "Voting Member" by removing the words after Master Masons "who hold an Elected or Appointed office of a Constituent Lodge".

RESOLUTION: Jurisprudence Committee moves that the definition C.0.19 "Voting Member" to read as follows: "Voting Member" means a Worshipful Master, Senior Warden, Junior Warden or Past Master and all Master Masons.

What You Didn't Know About Victoria Day

The Sovereign's birthday has been celebrated in Canada since the reign of Queen Victoria (1837–1901). May 24, Queen Victoria's birthday, was declared a holiday by the Legislature of the Province of Canada in 1845. After Confederation, the Queen's birthday was celebrated every year on May 24 unless that date was a Sunday, in which case a proclamation was issued providing for the celebration on May 25.

After the death of Queen Victoria in 1901, an Act was passed by the Parliament of Canada establishing a legal holiday on May 24 in each year (or May 25 if May 24 fell on a Sunday) under the name Victoria Day.

The birthday of King Edward VII, November 9, was by yearly proclamation during his reign (1901–1910) celebrated on Victoria Day. It was not an innovation to celebrate the birthday of the reigning sovereign on the anniversary of the birth of a predecessor. In Great Britain, the birthdays of George IV (1820–1830) and William IV (1830–1837) were celebrated on June 4, birthday of George III (1760–1820).

The birthday of King George V (1910 to 1935) was celebrated on the actual date, June 3 or, when that was a Sunday, by proclamation on June 4. The birthday of King Edward VIII (1936) was also celebrated on the actual date, June 23.

King George VI's birthday, which fell on December 4, was officially celebrated in the United Kingdom on a Thursday early in June. Up to 1947 Canada proclaimed the same day, but in 1948 and further years settled on the Monday of the week in which the United Kingdom celebration took place. George VI reigned from 1936 to 1952.

The first birthday of Queen Elizabeth II, in 1952, was also celebrated in June. Meanwhile, Canada continued to observe Victoria Day. An amendment to the Statutes of Canada in 1952 established the celebration of Victoria Day on the Monday preceding May 25. From 1953 to 1956, the Queen's birthday was celebrated in Canada on Victoria Day, by proclamation of the Governor General, with Her Majesty's approval. In 1957, Victoria Day was permanently appointed as the Queen's birthday in Canada. In the United Kingdom, the Oueen's birthday is celebrated in June. Submitted by WBro Colin Reichle (191)

The Conference of Grand Masters of North America (and) The Conference of Grand Secretaries of North America

Calgary, Alberta, Canada February 20-22, 2005 (6005)

Conference Report by: MWBro Rod Ponech, Grand Master — Alberta

The Conference of Grand Masters of North America and the concurrent Conference of Grand Secretaries of North America is an annual event bringing together the leaders of Freemasonry from around the world.

The membership in the conference includes the 10 Canadian Grand Lodges, 50 from the American states and one from the District of Columbia, the American-Canadian Grand Lodge with jurisdiction over military Lodges in foreign lands, and the York Grand Lodge from Mexico.

In addition there were observers from the Grand Lodge of England, several Mexican states, the Grand Lodge of Iran in exile, a number of European Grand Lodges, including France, Bulgaria and Romania, and scattered observers from around the globe. Delegates to the two conferences, observers and spouses numbered well in excess of 650 in total.

This was only the second time in the nearly 80-year history of the Conferences that the location had been outside of the United States of America. Interestingly enough, the only other non-American site had also been Calgary in 1987. Our Western Hospitality, Canadian, Albertan and in particular Calgarian was well received.

The Sessions actually began on Friday the 18th with a number of Committee meetings, including one for the CHIP—Child Identification Program—which I attended along with the Senior Grand Warden, RWBro Malcolm Berry. I am privileged to be one of the two Canadian representatives for this initiative and Malcolm Berry has been doing much of the preparatory work for the Alberta program proposal.

Saturday featured a convoy of busses making the trek to Banff for a day of sightseeing and a featured lunch at the Banff Springs Hotel. Many of our guests received their first (but we were assured not last) Canadian Rockies experience. That evening, most attended a western "round-up" at the Calgary Shrine centre and were introduced to line dancing, the two-step and even some square dancing.

The Conferences held formal ses-

sions on Sunday, Monday and Tuesday, and included a number of very informative "break-out" sessions on Officer Training, Public Relations, Youth Groups, the Chip Program, Technology in Masonry, the Masonic Service Bureau, and numerous other topics. From Alberta's standpoint the exposure to the variety of programs and innovative ideas made the Conference invaluable. Freemasons in Alberta and the Northwest Territories are part of a worldwide fraternity and it is imperative that we remain current on what the rest of the Craft is doing.

The Sunday lunches were arranged around Grand Lodge Offices as Marilyn and I joined the other Grand Masters, Rex Dawson and Marj dined with Deputy Grand Masters from around the world, and Malcolm and Dawn Berry with Bob and Lorraine Drury lunched with the Grand Wardens in attendance. Rex, Malcolm and Bob are now part of an informal organization called "The Future Grand Masters of North America." Their contacts and the information channels now open to them will be very beneficial to our Jurisdiction in the years ahead.

Sunday evening found all of the Grand Lodge Officers and their ladies from Canada meeting together over dinner. Following dinner our jurisdiction hosted a reception for the Canadian Delegates and their wives. This offered a rare opportunity for some informal discussions of issues and programming unique to our nation The "All Canada Conference" in April will be all the more beneficial as the group of men who meet in Winnipeg will already know one another, and plans for national programming initiatives and inter-jurisdictional cooperation have begun.

The Grand Secretaries from around the world met in separate sessions for much of the time and attended to a variety of managerial and administrative items, which must be coordinated to keep our fraternity in harmony around the globe. Issues such as Grand Representatives, CDs as compared to printed proceedings, electronic communications and such were discussed by those

who actually deal with the issues on a day-to-day basis.

Our own Grand Secretary, RWBro Jerry Kopp, was a member of the planning committee for both of the Conferences and played a key role in the Grand Secretaries' program.

During the Conferences there were a number of committee and program meetings. I was on the planning committee for this year's conference and we met several times. Of course there were also formal Banquets for the Grand Secretaries' Conference on Monday evening, and the Grand Masters' Conference on Tuesday.

By the time Wednesday morning rolled around, and the delegates were heading off to the airport for flights around the continent and in fact the world, there was a general feeling of accomplishment and satisfaction in the progress being made in Freemasonry.

For five days the leaders of Freemasonry met in Calgary and reinforced their commitment to the ideals of our ancient Craft as well as their commitment to cooperation and fraternal relations with a diverse group of independent Grand Lodges around the world. While the deliberations and recommendations of such conferences are not in any way binding on the Sovereign Jurisdictions represented, the sense remains that such meetings are absolutely essential if we are to hold this loose web of Freemasonry together.

All Alberta Masons owe a huge debt of thanks to MWBro David Bruce and his committee, as well as the dozens of volunteers from the Calgary region who made these events such a resounding success. The list of names is too lengthy to list, however I trust that each person involved understands that our gratitude is genuine.

As a final comment let me attempt to answer the underlying question which surrounds any of our conference or meeting participations (and expenses). Is it worth it? In a word, Yes! The leadership of this Craft in Alberta, for several years to come, is now much better prepared to serve each Mason in the Jurisdiction.
