Introducing MWBro Gerald D.R. Waldern

MWBro Gerald D. R. Waldern was installed as the 106th Grand Master of the Grand Lodge of Alberta A.F. & A.M. on 12 June 2010.

Born in Lethbridge on 14 September 1955, he is married to Pamela and they have two adult children and three grandchildren. For a number of years he worked in the construction industry as a project manager and partner in a commercial general contracting business. This was followed by post-secondary studies in the areas of Industrial Labour Relations, Public Administration and Political Science. In recent years he has been the proprietor of Lethbridge Tax Time Centre, a tax preparation firm in Lethbridge.

In the community, our Brother served as a Public School Board Trustee for Lethbridge School District No. 51 from 1991–1998 and as a Trustee of the Alberta School Employee Benefit Plan from 1995–1998. He is also a Past President of Galt No. 8 Mine Historic Site Society.

MWBro Waldern was initiated, passed and raised in North Star Lodge No. 4 in 1977 and served that Lodge as Worshipful Master for four terms: 1981-1982, 1983–1984, 1995–1996 and 2000–2001. He served the Grand Lodge of Alberta as DDGM of Chinookarch District for 2004–2005, was appointed to the Board of General Purposes for 2006-2007 and elected for a 3-year term from 2007-2010, was appointed a member and Chairman of the Finance Committee from 2006-2010. He was elected as Junior Grand Warden at the Annual Communication in 2008 and Deputy Grand Master in 2009. MWBro Waldern also serves as the Grand Representative of the Grand Lodge of Montana near Alberta. In addition to Craft Masonry, he is a member



of the Royal Arch Masons, Cryptic Rite Masons, Knights Templar, York Rite College, Red Cross of Constantine and Shriners International.

MWBro Gerald Waldern's Inaugural Address Retention, Revitalization and Renewal

Part one of two

My Brothers:

I am extremely honoured and humbled today by the honour that has been bestowed upon me of being installed as Grand Master. It is an undertaking that I take on with the full realization of the magnitude of my duties and responsibilities to our jurisdiction for the welfare of our beloved Craft. In my opinion, the first and foremost duty of the Grand Master can be summed up in that well known phrase "to serve and protect." Service to the Craft and the protection of our Constitution, Regulations and Ancient Landmarks will be my guide when setting direction and making decisions and in carrying out my duties this coming year.

In our respective Lodges the question is posed as to the duties of the Worshipful Master and why he is in the East. As we all know, the answer, depending upon your rite, is "to set the Craft to work and give them proper instructions for their

labours," or "employ and instruct the Brethren in Freemasonry." Similarly, the Inaugural Address for the Grand Master is an opportunity to give proper instructions for labours for our Lodges and membership by way of a theme setting out the aspirations and directions for the coming year.

In 2008, senior Grand Lodge Officers developed a **Strategic Plan for the Grand Lodge of Alberta** that was adopted at last year's Annual Communication. The purpose of the Strategic Plan is to "Strengthen Our Lodges" over the next five or so years, with a realization that steps towards this overall goal would develop each year. In keeping, therefore, with the purpose of our Strategic Plan and its implementation, I have chosen as my theme **Retention**, **Revitalization and Renewal** and wish to attempt to articulate to you today some thoughts.

First, I want to set out some of the actions and directions that are going

to be happening for the coming year. Leadership training courses were one of the main items identified in the Strategic Plan that were needed in this jurisdiction. Therefore, rather than having a Grand Master's Tour, I want to focus my travel and efforts this year in bringing about leadership training sessions within our Districts. Earlier this year at the Grand Lodge Officers orientation session. I instructed our District Deputy Grand Masters to arrange for a joint meeting of the Lodges within their Districts for the purpose of holding basic leadership training sessions that will be of value to our Lodges. Where it is more desirable and effective to hold these training sessions jointly with a neighbouring District or Districts, then the District Deputy Grand Masters of those Districts are to work together to bring this about. Dispensations will be granted so that Lodges may bring their Charters for the holding of such a joint

I realize fully, as I believe most of our District Deputy Grand Masters do, that

I would encourage Lodges who are struggling to come to the Grand Lodge Communication and meet with those Lodges that are doing well and find out what is working and what doesn't work.

active in visitations and exemplary in ritual work and attends installations, workshops and Grand Lodge as frequently as his health permits. He has assisted with the catering of the Lodge's festive boards for 15 years, has written and presented several Masonic papers and demonstrates the positive aspects of Freemasonry.

He is devoted to building a strong Masonic brotherhood and family. He is a past Bethel Associate Guardian of Job's Daughters, a supporter of DeMolay (grandfather of the 2008/09 Alberta DeMolay Coordinator), Past Patron (five times) of the Order of Eastern Star, a member of the Al Shamal Photography Unit and active in many functions in the Nile.

In his community life, Bro Blue has managed baseball and hockey teams and is very active in fund raising for the Greenfield Community League, especially for their first building. As Treasurer for this community's hockey committee, he organizes and manages the hockey program and is very hands on, as he puts up and then takes down the hockey rink's boards.

Bro Blue is recognized for his humble personality and is able to exemplify and communicate the sound tenets and principles of our noble Craft. Rather than his being concerned about his own poor health, his warm, genuine and reassuring tone of voice fosters harmony in the Lodge and serves as a pillar of moral strength and a beacon of light to lead others.

Happily married to Jeanette, which union has produced three children, they are blessed with seven grandchildren. This couple will be celebrating their 49th anniversary in 2010. One daughterin-law stated, "Neil is a real seeker after truth and willingly shares this knowledge with family and friends." As a vocation, Bro Blue is an accountant who had his own professional practice for many years.

Bro Harry Robert Stuart (**Robin**) **Carson** was initiated into Freemasonry on 19 April 1976, passed to the Degree of a Fellowcraft on 21 June 1976 and raised to the Sublime Degree of a Master Mason on 20 September 1976. He is currently a member of Evergreen Lodge No. 166.

Bro Carson has held the position of Chaplain for four years and always performs his duties in a dignified way and with conviction, preparing his graces with a fine sensibility. He is active on the Benevolence Fund and the Research and Education Committee. He is involved in many activities: Fort Edmonton Masonic Museum coordinator, assisting the DDGM in the designing of the poster for the Riverboat Excursion, annual community clean-up and many fundraising projects. He is instrumental in the process of having the sacred book of the respective candidate's faith available during degree work. Bro Carson is a very effective mentor of new Masons and has not only stayed with them through the degrees, but has helped one of his charges, who was new to our country, to deal with problems typically faced by new immigrants. He is involved with the presentation of papers and assists other Brethren to polish their own papers so as to add more meaning to our meetings. He chairs the Sick, Visiting and Widows Committee and is influential in the formation of a Christmas Tea for the Widows, following which they receive a Christmas cake.

Bro Carson was in the teaching profession from 1968 until 2001 with the Edmonton Public School Board, where he taught English, Drama and Latin. For a number of years he was head of the English Department at Victoria Composite High School and taught theatrical makeup at the University of Alberta and Banff School of Fine Arts. Since 2002 he has been active in the Northern Alberta Brain Injury Society (NABIS) as librarian, has worked on their newspaper and practices communication skills with a class of injured clients. He has worked on the staff of a local magazine called On Spec, editing stories, and in this way works with Canadian and international writers. He has also assisted two Masonic Brethren with their Masters theses. In addition, he volunteers his time as a copy editor for conferences.

Bro Carson does everything he can to assist his two children, particularly one who has a painful, chronic medical problem, and is a proud grandfather of two. He assists his life partner, Susan, who is a private music teacher, by building production sets for her students' recitals. They have created a wonderful, fulfilling and benevolent life.

His nominators say "that in the hearts

and minds of all Brethren who know him, he is the ideal of a true Mason."

Bro Francis Leroy Dryden was initiated into Freemasonry on 21 October 1993, passed to the Degree of a Fellowcraft on 2 December 1993 and raised to the Sublime Degree of a Master Mason on 20 January 1994. He is currently a member of Exemplar Lodge No.

175 and Griesbach Lodge No. 191.

Bro Dryden has served his Lodge as Secretary for 16 years, participates in virtually all Lodge events and has made significant contributions to the direction and leadership of the Lodge. He has played key roles in the social life of the Lodge and has personally sponsored dozens of candidates, acting as their mentor and guiding them through the process of petition and degrees and integration into the life of the Lodge. He organizes an annual Lodge BBQ, with proceeds directed to a charity and matched by the Foundation. In addition he is very devoted to Athabasca District and their activities and serves as assistant to the DDGM.

He is well-known in Edmonton and is a strong ambassador for Freemasonry. He receives many inquiries directed to Freemasons' Hall and is diligent in referring potential candidates to the various Lodges, where they might best fit with regards to location, time available and the character of the Lodge. He is active in many community events, Director/Secretary of the Temple building association and a member of Al Shamal Shrine.

On the personal side, he is an avid musician and very active in the Edmonton arts community. He has a degree in Radiotherapy and worked as a Real Estate Agent for over 20 years. His partner in life is Anastasia Boyd. His community activities include Director of The Pillar Society/Westlawn Seniors Centre and membership in 418 Squadron Association.

Bro George Douglas Leigh-

ton was initiated into Freemasonry on 15 September 1992, passed to the Degree of a Fellowcraft on 20 October 1992 and raised to the Sublime Degree of a Master Mason on 17 November 1992. He is currently a member of Eastgate Lodge No. 192.

Bro Leighton has been a strong member since being initiated. After commencing through the chairs of the Lodge, he decided that it was probably too much for him. However, he continued on in the position of Registrar for a couple of years and then as Secretary for several years, a position he continues to back-up since stepping down on a full time basis. He is a regular attendee and active participant in degree work, both for Eastgate and to assist other Lodges. He is a good visitor and has been the Lodge coordinator for Fort Edmonton Masonic Museum for over 10 years.

In addition to his Lodge, Bro Leighton is Secretary of the Director's Staff, Al Shamal Shriners, is a member of the Ionic Club and assists in various fund raising and special projects.

George is the youngest of five brothers and one sister. He met Ann while working for Canadian Utilities in Sexsmith, Alberta, where they were married in 1957. They were married for 43 years before Ann passed away in 2001. The family has been blessed with three children, five grandchildren and one great-grand child. His father, John, was a Past Master of Kitscoty Lodge No. 131, and his brother Arthur was a Past Master and also served as Secretary of that same Lodge.

He has been a strong community-minded person for many years, serving as President of High Park Community League and coaching Little League Baseball — including taking a team to the provincial finals. Since retiring from ATCO Electric, he has been a strong volunteer for the Odyssium (Edmonton Space & Science Center), assisting them on a weekly basis for 16+ years.

His nominators state, "In all the years we have known George, he has always worked tirelessly behind the scenes, assisting with whatever was needed and never looking for recognition or praise. This would certainly be the personification of a true Mason."

Bro Bruce MacLaren was initiated into Freemasonry on 19 September 1967, passed to the Degree of a Fellowcraft on 17 October 1967 and raised to the Sublime Degree of a Master Mason on 21 November 1967. He is currently a member of Mosaic Lodge No. 176.

Bro MacLaren is an active member who attends Lodge on a regular basis and is always willing to assist wherever needed. He is a generous donor and eager participant in the Lodge's annual pre-Christmas shopping trip to purchase items for a local family in need. He is the main force in the purchase of and

delivery of poinsettias to the widows of deceased members. He is noted as humble and unassuming, never looking for personal recognition or credit, and an excellent role model for younger members and indeed for all members of the Lodge.

In addition to his Lodge, he was Potentate of Al Azhar in 1991 and is a strong supporter of the Children's Hospital and other Shrine activities and clubs in Calgary and surrounding rural centers. He is a member of the Ancient and Accepted Scottish Rite, Red Cross of Constantine and the Order of Eastern Star.

Bro MacLaren was raised on a farm, and being the eldest of five children was active in assisting in the care of his siblings. With his father and brothers serving in the military during WWII, he remained on the farm with the responsibility for most of the farming activities, fixing machinery and doctoring the animals. He has been happily married to Betty for 62 years, raising two daughters

who have given them four grandchildren. After working for The Bay for 25 years, he started his own business of buying and selling used furniture and appliances, keeping the family active in this successful venture.

He is noted as a fun loving, energetic individual who loves people and works with the Calgary Food Bank several days a week. Each December he spends much of his time volunteering in this very worthwhile pursuit at a time when most others are fully absorbed by their own lives and families. In addition, he volunteers at the Mustard Seed, is active with the Triwood Community Centre, helping kids and their coaches with hockey skills development and has served as an elder in the St Giles Church for many years.

Freemasonry, Education and the Masonic Higher Education Bursary

Congratulations to you all! For three years in a row the Masonic Higher Education Bursary Fund has been able to provide 100 - \$2,000 bursaries to the young adults of Alberta and the Northwest Territories. The Brethren have all done a super job raising money for Alberta's youth, particularly those from: Chinook-Spitzie Lodge and the recently formed Aurora Borealis Lodge; Beaverhills, Mighty Peace and Alpha Districts; the Tuscan Society; and the Calgary Masonic Temple Board. In addition, the Al Shamal Clowns, the Strathmore Temple, and the excellent effort by the Stampede DeMolay have all contributed to the future of these young adults. Thank you.

Education has always been important to Freemasons. The early stonemasons had a unique interest in understanding geometry, the forces of gravity and the characteristics of soils and stone. Subsequently, members of the Royal Society (1662) — Dr. James Anderson (1680–1739), William Preston (1742–1818), etc. — all had an interest in knowledge and education, particularly with the education and improvement of men and society. More recently, in 1788, the Royal Masonic Institution for Girls was formed by Bartholomew Ruspini and nine fellow

Masons. The Royal Masonic Institution for Boys followed in 1798. Their purpose was relieving the poverty and advancing the education of children of deceased and distressed Freemasons. In 1986 this role was assumed by the Royal Masonic Trust for Girls and Boys. (See http://www.rmtgb.org/)

In the beginning we do not consciously decide to go to school or undertake the start of our formal education process. It is all arranged by our parents: the clothes, the books, the transportation arrangements, etc. But the decision to go to college or university is largely our own. Entrance requirements, the selection of a course of study, the institution, where to live and the funding requirements are all aspects that the young adult has to decide or come to terms with. The whole process makes the decision both daunting and exciting. For some of these young adults the funding requirements to attend a college or university become too much and, unfortunately, they are forced to surrender their aspirations and dreams to the reality of their situation.

In 1956, MWBro Ross Sheppard (1888–1961), an Edmonton Public School Superintendent, who had similar interests in education as his ancient Brethren,

had a vision for Alberta Freemasons to put to work the Masons' interest in education the philosophy of charity and being benevolent by the creation of the Masonic Higher Education Bursary. Ross Sheppard, like those before him, had a clear understanding that education reduces the cycle of poverty, allows us to pursue our dreams and improves the quality of life not only of the individual but also of society as a whole. He clearly understood that Alberta Freemasons could be an important part of helping the young adults of Alberta and the Northwest Territories with the daunting but exciting task of obtaining a higher level of education.

As October is Masonic Higher Education Bursary Month, I request that each Freemason and each Lodge ask the questions: How can I help? How can I help reduce the cycle of poverty? How

can I help someone with their journey of life? How can we contribute to our community?

You can help by organizing a fundraising event, a raffle, a festival banquet, a golf tournament or a cribbage tournament and sending the excess proceeds to the Masonic Higher Education Bursary Fund. Whatever you do, the results of your endeavours will be appreciated by those young adults who are starting a new adventure on the road of life.

In 2009 the Masonic Higher Education Bursary Fund received \$152,184.83 in donations. Institutional and concordant bodies donated \$83,026.71 and Freemasons and Lodges in the jurisdiction donated \$69,158.31, or \$9.36 per capita, as opposed to \$9.58 per capita in 2008 and \$10.79 per capita in 2007.

The District with the highest per capita contribution was Beaverhills with

\$20.06, while the Lodge with the highest per capita contribution was Chinook-Spitzie No. 6 with \$45.08.
