practicing in Alberta since 1992. He has worked for a wide range of firms, both large and small, and currently operates his own practice as the principal of Craft Law Group. Nearly one-third of his career was spent with Suncor (2005-2013), which involved a move up to Fort McMurray where he joined Lodge. As to Kyle's Masonic journey, he



expressed interest in Masonry as early as 1998, but circumstances deferred his application until he signed up to join a Lodge in Calgary in 2004. Suncor sent him North in early 2005 before he was scheduled to be initiated, and so he was instead initiated, passed and raised as a Master Mason between January and May 2006 in Millennium Lodge in Fort McMurray.

Kyle served as secretary of Millennium Lodge from 2006 through 2009, and then as Treasurer 2009-10. RWBro Scott became a Charter Member of Aurora Borealis Lodge No. 201. As a result, Kyle has been involved in "both sides" of the Craft as his mother Lodge is Canadian Rite, while Aurora Borealis is York Rite. Kyle took on the role of Secretary-Treasurer of Aurora Borealis in its formative year of 2008-09, setting up the books and serving as the lead draftsman for the new Lodge's By-laws. He was then elected Junior Warden for 2009, progressing through the Chairs to serve as Master in 2011-12. Despite Suncor transferring Kyle back to Calgary in 2012, he has remained active with his two Lodges in Fort McMurray and within the Athabasca District, serving as DDGM for the District for the 2014-15 year. He continues to visit the Lodges in his District Kyle has served in the office of Piper for Exemplar Lodge No. 175 in Edmonton, and will continue his tradition of Piping in Exemplar at the Masonic Spring Workshops.

RWBro Scott's Masonic journey has expanded beyond Craft Lodge, and across a large portion of our Jurisdiction. He progressed through Royal Arch (Hangingstone #40 Fort McMurray) to Cryptic Right (Zohar Council, Edmonton) and Preceptory (Edmonton No. 46), Scottish Rite (32nd degree, Valley of Calgary) and he joined the Al Azhar Shrine following his return to Calgary (October 2012), serving with the Mounted Patrol, the Provost Corps and also as a member of the Vintage Car Club. He has more recently affiliated with Otuskwan Royal

Visitation is the one of the great foundations of our Fraternity. There is no better way to gain knowledge regarding the pulse of a Lodge or a Lodge District than through visitation. The Brother can then return to his mother Lodge and report what and how their sister Lodges are doing and implement changes for the betterment of their Lodge. I would engage in discussions relative to having the three principal officers of a Lodge set a schedule for visitation every month that they meet and provide a positive/ negative report to their Lodge of their experience.

Final Thoughts

As a young boy, I remember when the Shriners came to Winnipeg for a convention. That impression eventually brought me to the doorstep of Freemasonry with becoming a Mason in January 1970. My sponsor was a neighbor with whom he and his wife became close friends and surrogate grandparents to our children, Cindy and Jason. Balancing work then, even today, as a young family choices had to be made resulting putting aside a number of things including the craft. Eventually, as times improved, I became reinvolved with Masonry with the support and encouragement through a friend. This lead me to proceed through officer chairs in St. Mark's Lodge to becoming Worshipful Master in 2007 as well as serving in several capacities within the fraternity. Lodge visitation became a new found family of friends. The hand of friendship was a strong bond and to share that bond has been my focus ever since.

Encourage what is good and put it to more effective use with self-affirmation to embrace the future positively. To place my name forward to be a Grand Lodge officer did not come without long thought, consultation with others and finally consultation with my wife. The challenge – "Our Craft (and most of the concordant bodies) continues to decline in numbers" and "Can we reverse this trend?"

A number of our recent Past Grand Masters have worked to address this issue of declining numbers within many of our Lodges, and the overall trends for our Jurisdiction as a whole. This has included promoting more education within the Lodges and initiatives to reorganize and re-invigorate the Craft. Key elements of these efforts have included improving the candidate introductory experience with variations of the "7 Step Process", among other initiatives. I, for one, believe that the administration of our Lodges is stronger now than five years ago, that most Lodges are doing a better job managing candidate intake (and the overall candidate experience) and that these positive initiatives are spreading throughout our jurisdiction. However, we have a fundamental issue with attracting sufficient young men to our ranks. The "To be one, ask one" and similar campaigns do not appear to be having a major impact. While most every Lodge in Alberta continues to attract Petitions for Initiation with qualified candidates, our losses (of Brethren leaving for whatever reason, many joining the Grand Lodge Above) continue to outweigh our gains. This is nothing new. However, I feel our reluctance to "encourage" young men to consider our Craft has an impact, with some of this reluctance tied to our apparent prohibition on "recruiting". Yes, there is a Masonic offence for "improper solicitation of candidates" - it is found within the Constitution (C&R 1.u.21.1.c.1.I). As the current Chairman of the Jurispudence Committee of the Board of General Purpose, I would have a hard time interpreting what would constitute "improper solicitation", as I assume that we are not discussing the introduction of the equivalent of 19th Century Royal Navy Press Gangs.

One of my favourite authors since I was a young man has been Tom Clancy. In a number of Tom Clancy novels where issues of complying with the (U.S.) Constitution come up, the main character, Jack Ryan, uses a quote more than once in these novels – "the Constitution is not a suicide pact". That is, if strict compliance with the Constitution guarantees the failure of the organization, then a more flexible interpretation of the

meaning and intent of the clause(s) in question is called for.

I do not imagine we will return to our heyday of the mid-1970's in this Province, where we had 3 times as many members as we do today. The trends in our Society over these 40+ years make that clear. However, the overall population of our Province has roughly tripled in that same time period. In other words, we are 1/9 of what we once were. In effect, for every 9 Alberta men deciding to join Masonry 45 years ago, we now have 1 submitting a Petition.

There was a famous series of Shampoo commercials from that era - "You tell two friends, and they tell two friends, and so on, and so on ...". I am proud of continuing to meet and refer good men to the Craft, and I am most definitely not alone. If enough of us are "telling friends" about our membership within Masonry (and yes, I respect that many Brethren desire to keep their membership secret for any number of reasons), and getting those friends to consider it, and hopefully, Petition to join a Lodge that suits them, we will arrest the decline and build positive momentum. No other changes expected to the sponsorship and interview process, as integral parts of our improved candidate screening and preparation processes.

"To be one, ask one" needs enough of us "ones" to be active in our spheres of influence identifying good men and encouraging them to consider the Craft (or, if they have issues with Masonry, to consider another less traditional service organization). Our Craft will be stronger (many will continue to choose Masonry), and overall, our communities will be stronger.

And with a stronger Craft, made up of a larger and larger proportion of younger Men, our institution will, as it has for ages, continue to adjust to the Society (of Western Democracy) that we helped to create as our Society continues to evolve around us, and evolve it continues to do, at an accelerating pace. As a Brother whose initial University studies included History, I have my thoughts on "broad brushstrokes" of these changes and how they have been impacted by (or have themselves impacted) our Craft.

Let us not forget that Masonry was at the forefront of the Enlightenment. As someone with the last name "Scott", I could not help but read a book published in 2001 entitled "How the Scots Invented the Modern World" (written by an American of Norwegian ancestry then working at the Smithsonian – Arthur Herman). It ended up being a bestseller. It traces the beginnings of the enlightenment in Scotland, which by the late 18th century had become the most literate country on earth, and Masonry, encouraging its members to read, learn and make their own judgments on issues, went hand in hand with that growth (and likely helped spurit). Our organization of Lodges, which evolved into having democratically elected leaders, with a peaceful transition of power between leaders, and then growing that into the Grand Lodge system 300 years ago, laid the foundation for modern democracy (first created with the birth of the United States, of which virtually all of the founding fathers were our Brethren). When talking to a prospective candidate, and I am asked about our Craft, I often reply (to those I know to be mindful of their history) that one of the more Masonic historical statements, written by a famous Mason, is "We hold these truths to be self evident, that all Men are created equal, ...".

However, within my lifetime (and I would like to think that I am not too old at 54), we have witnessed a reversal of the Enlightenment and its emphasis on learning based on logic and critical thinking. An even earlier bestseller (published in 1987) was Allan Bloom's "The Closing of the American Mind". According to Professor Bloom, beginning in the early 1960's, we have seen a drift away from critical thinking and free speech (a by-product of "moral relativism"), a "watering down" of education standards (teaching to a lower common denominator), and a resulting general lack of respect for (and knowledge of) the past and of enlightenment principles. A "de-Enlightenment" as it were.

Difficult reads, but both poignant, and they set forth a key issue. Our venerable institution was central to the Enlightenment, the expansion of learning throughout society, the growth of the middle class, liberal democracy, and yes, the modern world itself. However, I agree with the observations of Mr. Bloom, and that we have been experiencing a de-Enlightenment over these past 50 years. Masonry's response has been to close ranks and to cling to our traditions. We, who were at the forefront of positive changes in our overall Society, have retreated. The results are clear for all to see (in our declining

membership). I would not be a Mason were I not a believer in the teachings of the Enlightenment-that every Man can improve his station through learning, and that, "if you are going to bother to do something, you may as well do it right !" Let us understand that we are the champions of the Enlightenment, and rather than resist society's changes, continue to espouse our doctrines, not to resist change, but to continue to promote improvement, to our members and to our society as a whole.

Masonry has been around from time immemorial because it is valuable, it is an attitude of how to live ones life ("the pursuit of excellence in all areas of our development - morally, socially, in our masonic work or otherwise"; and "learning is a lifelong pursuit"; etc.). These character traits embodied by Masons will, if we properly convey our benefits, attract respectable men. The ambition of every Mason (and every Lodge and Grand Lodge Officer) should always be this relentless pursuit of living as an honest man with an open mind (and conveying these messages).

As a Lodge Secretary, Treasurer, Warden and Master, and as a Grand Lodge appointed Officer, a District Deputy Grand Master, Board of General Purpose member and Jurispudence Committee Chairman, I have a solid understanding of our Lodges' and our Grand Lodge's administration. This will continue to evolve with input from all members, and I have always enjoyed working with Brethren from across the Province when initiatives are brought forward in an effort to improve our administration. I will continue to do so, but I do not intend this to be my main focus. As set forth above, should I be honoured by the Brethren of our Grand Lodge as their selection this year to join our Grand Line, I will make my priority improved communication, with the direction to all Brothers to spread our message and our good works, with a stronger "encouragement" to those many men who, if made aware of Masonry and what we have to offer, will strongly consider joining our ranks.

After lengthy reflection and serious contemplation on the current condition of Freemasonry in our Grand Jurisdiction, I have decided to put my name forward as a candidate for the position of

Junior Grand Warden. This is a decision that is not taken lightly and will require commitment and dedication over this lengthy journey. I am not putting my name forward to bask in the limelight, to inflate my ego or to chase aprons. It is out of a sincere desire to serve the craft in an attempt to help rebuild the foundations of the great Fraternity which has given so much to me and to the rest of you brethren.

I joined Freemasonry in 1996 in large part due to the high regard that I held for my grandfather and uncles, as many of you may have experienced. I wanted to emulate them in every way and become the type of men they were. The evening of my Initiation into Patricia Lodge was one of the most profound moments of my life. In that moment I could not have anticipated how much Masonry would positively affect my life, or the influence it would have in making me the person I am today. From the very beginning of my Masonic journey it was instilled in me the belief that Freemasons should be the moral pillars of our communities and that we should always strive to conduct ourselves as such. From that day forward I have tried to live up to that ideal not only inside the lodge but more importantly outside the lodge. In the past few years I have had the pleasure of raising my son to the Sublime degree of a Master Mason and installing my cousin, the fourth generation of our family, into the chair of King Solomon with the wish to ensure that our Fraternity remains strong and vibrant for generations to come.

When you look at the condition of Freemasonry within our Grand Jurisdiction, there are numerous positive aspects, but there is cause for concern. We are losing not only members, but lodges at an ever increasing rate. The craft is at a crossroads and we must decide what direction we are going to take Freemasonry. We need to concentrate on strengthening the fraternity as a whole. It is time to rebuild the foundations of not only the lodges in our jurisdiction but the craft as a whole.

I would propose we start by holding a series of district and multi-district round table discussions and events. We need to listen closely and engage all brethren in the formation of a road map forward. Look at what is working for the lodges and then compile best practices of Masonry for dissemination to all lodges. A great example of this is

the recently adopted "Seven Steps to Initiation" program. This was a lodge driven program which is spreading across the jurisdiction. This may be a primary means to reach out to the membership to decide on a path they believe should be taken to reinvigorate our great Fraternity.

We need to look at re-envisioning the roll of the DDGM from a reporting officer to more of a mentor charged with strengthening the Craft within their district by helping to facilitate Lodge Officer Training, Lodge Management Training, Ritual work clinics as well as Masonic Ritual Education at their District Lodge level. It is time to get back to the basics of Freemasonry.

We need to create a robust lodge officer training and lodge management program. This has been done in the past but never really worked, so why didn't it work and what do we need to do to make it work?

The Grand Lodge should be utilizing their DDGMs and other experienced brethren to assist in better training the officers of the lodges in their districts not only in the ritual side of the meetings and degrees, but more importantly in the proper management of the lodges.

We should look at all lodges to determine their strengths and weakness. Many lodges are doing amazing ritual work but at the same time there are an equal number of lodges struggling with not only the execution of the ritual but understanding of the ritual. Some sort of a mentoring program needs to be developed and put in place to assist these lodges. Having a degree team come in and do the work assists some of the lodges but it does not deal with the core problem.

We should work with the districts as well as the lodges to set up a comprehensive lodge education and management program. This program should be multi-faceted with a number of different modules or courses such as Masonic Ritual Training, Lodge Management, Masonic History, Philosophy etc. By better educating our brethren, and having them develop confidence in their work and themselves, we will create stronger, more vibrant lodges.

Finally lodges should become more visible in our communities to show that we have something to offer to today's evermore superficial society. Our lodges teach many skills often untaught, or not experienced, elsewhere. A brother must speak in public, think on his feet, make decisions, vote on issues or chair meetings. These are invaluable assets in all other aspects of his life and for many, this may well be the only opportunity of learning, practising and perfecting these skills and techniques. By improving the men in our society we help improve our society as a whole.

It is imperative that this process be member driven to rid the perception that Grand Lodge is not listening. All members of the craft from the newly initiated up to the Grand Master need to work harder on strengthening the bonds of brotherhood. We must reinforce in all the brethren the meaning behind Brotherly Love, Relief and Truth.

Brotherly Love "Every true freemason will show tolerance and respect for the opinions of others and behave with kindness and understanding to his fellow creatures."

Relief "Freemasons are taught to practice charity and to care, not only for their own, but also for the community as a whole."

Truth "Freemasons strive for truth, requiring high moral standards and aiming to achieve them in their lives.

We should look at these Three Great Principles of Masonry and view them as the measuring stick by which every action should be measured. Every action taken by the Lodges, Grand Lodge and more importantly the Grand Line offices should be done with the goal of improving harmony and promoting good will throughout the Craft.

Thank you brethren for all your support and encouragement in helping me make this important decision to run for Junior Grand Warden. So in conclusion, I hope to be able to help reinvigorate Masonry in our province and see lodges flourish once more while leaving behind a fraternity that will better the lives of its members and society for generations to come.

Motion 2019-02 — Capital Reserve Fund

Preamble

There is a need to address the way funds are taken from the General Capital Reserve Fund and where it is deposited. The repayment process is removed.

- d. The investments within the General Capital Reserve Fund may be used, as deemed necessary by the Grand Treasurer and the Finance Committee., through a process of borrowing funds from the Capital Reserve Fund, for deposit into the Grand Lodge General Account. Such funds to be considered a line of credit which must be returned to the Capital Reserve Fund. Any withdrawal from the fund should be deposited into the Grand Lodge General Account. All transactions must be approved and monitored by the Grand Treasurer and the Finance Committee.

Motion 2019-03 — Affiliation

Preamble

There is a need to provide greater instruction and clarification for those Masons who wish to affiliate with a Lodge in this Grand Lodge Jurisdiction but have not received the degree of Master Mason.

MOVED by: Jurisprudence Committee

THAT: II.3.G.2 Affiliation be modified to read:

- 2. Affiliation
 - j. An application for affiliation shall not be received by any Lodge from a Brother beneath the degree of a Master Mason, unless such Brother presents a Demit from a sister Jurisdiction which authorizes the granting of Demits to members in other degrees.

Should a Bother beneath the degree of a Master Mason from within this Jurisdiction (or from a sister Jurisdiction which does not authorize the granting of Demits to members in the other Degrees) desire to join another Lodge, he must submit a petition for initiation. If his petition is accepted, he must be initiated as an Entered Apprentice by his new Lodge and proceed to complete the three degrees. In all such circumstances, within this Jurisdiction the Brother must maintain his status with his former Lodge and only demit from his original Lodge following his attainment of the degree of Master Mason and/or take action as proscribed by the sister Jurisdiction where applicable. Lodges are cautioned to be especially diligent when conducting the review process for any such Brother electing this path.

Courtesy degrees for the Fellowcraft and/or Master Mason degree may be an option subject to the approval from the Mother Lodge and applicable Jurisdiction, if required. Once the Brother attains the degree of a Master Mason, he may then apply for affiliation.

Motion 2019-04 — Communications Committee Preamble

In the duties and responsibilities of the Communications Committee. Item 8, review and approve all masonic web sites, etc. is too broad to be implemented by one individual

or committee. **MOVED** by: Communications Committee

THAT: II.1.G.13 be modified to remove Item 8 and to read: The duties and responsibilities of the committee shall be to:

- 1. Develop an annual communications plan ...
- 2. Gather information ...
- 7. Attend quarterly meetings ...
- 8. Review and approve all masonic web sites, social media sites or other electronic applications, literature which may be broadcast to the public or the Craft within this Grand Jurisdiction ensuring compliance with the GLA Constitution and Regulations.

Motion 2019-0 — Grand Officers Preamble

Whereas: A Past District Deputy Grand Master or a Past Grand Secretary or a Past Grand Treasurer would have gained a working knowledge of the Grand Lodge and Committees it is desirable and appropriate that an officer presenting himself for the office of Junior Grand Warden, Senior Grand Warden or Deputy Grand Master has this knowledge

MOVED by: Temple-Centennial Lodge #167

THAT: I.1.H.8.1 be modified to read:

- 1. Where a Mason
 - a. Is a member of Grand Lodge, and
 - b. Has been regularly installed as a Master of a Lodge in this Jurisdiction, or
 - c. Has been regularly installed as a Master of a Lodge in a Jurisdiction recognized by Grand Lodge, and
 - d. Has served his term in that office, he is eligible to hold any office in Grand Lodge.
 - i. For the office of District Deputy Grand Master, he must be a member and a Past Master of a Lodge in that District, or an affiliated Past Master and have the rank of Past Master for two (2) full years prior to the Annual Communication next following his prospective election.
 - ii. For the office of Junior Grand Warden, Senior Grand Warden, Deputy Grand Master, he must be a member in this Jurisdiction and have served in the office of a District Deputy Grand Master, Grand Secretary or Grand Treasurer in the Grand Lodge of Alberta and have held the rank of Past District Deputy Grand Master, Past Grand Secretary or Past Grand Treasurer for two (2) full years prior to the Annual Communication next following his prospective election.

2019 Conference of Grand Masters of Masons in North America (COGMNA)

15 to 19 February 2019, Rapid City, South Dakota By RWBro Ken Cheel, DGM

The Grand Lodge of South Dakota hosted the 106th annual conference of Grand Masters of Masons in North America. The annual conference provides Masonic Leaders from Canada, the United States and Mexico a forum for dialogue on the challenges and opportunities facing Freemasonry in our rapidly changing and fast-paced world. Representatives from Alberta at this year's conference included the GM, Kenn Culbertson, the DGM, Ken Cheel, and the JGW, Terry Murray. The GSec., Bill Kostenuk was at the conference of Grand Secretaries which was held at the same time and place.

From the moment of arrival at the Rapid City airport, to departure, the Grand Lodge of South Dakota and its many volunteers were exceptional hosts. Transportation and volunteers were at the airport greeting delegates and making sure we safely arrived at our hotel destinations. Volunteers were at each conference hotel to answer questions from out of town delegates. Shuttle service was available between conference hotels, and for delegates to use for travel within Rapid City — for shopping, restaurants and for sightseeing of tourist destinations. This service was offered on a "donation" basis and all funds raised went to a South Dakota masonic charity.

The 2019 COGMNA embraced digital technology for the overall event and meetings administration — a first for the conference. Through the available app, delegates for the conference could customize their schedule, order and pay for tickets for events. Meeting organizers had ready access to ensure delegates had the authorization necessary to participate in each meeting or function. Overall, a quick and efficient process that streamlined event management and administration.

The 2019 COGMNA also changed the format of the conference from numerous breakout sessions on various topics concerning the Craft to keynote speakers, followed by a limited number of breakout sessions. The first keynote speaker was Sammy Lee Davis, a Vietnam Veteran, Medal of Honor Recipient and a fellow Mason. Bro Davis's talk focused on the circumstances surrounding him being awarded the Medal of Honor. Besides being a fascinating talk, it exemplified his character as a Mason. The actions he performed are outlined in the "General Charge" within the paragraphs of an ideal mason: can do, but where need is, will lay hold with dispassionate courage, circumspect resolution, indefatigable exertion, and a rare power of mind, and who will not cease until he has accomplished his work, but who then, without pretension, will retire into the multitude, because he did the good act, not for himself, but for the cause of good.

His response to the question "Did he find any difference between the Brotherly Love that he experienced in the service and the Brotherly Love found in the Fraternity" was immediate and forthright: "There is none. There is no difference between them."

The second keynote speaker was Senator John Thune, the senior senator from South Dakota. As he was unable to be at the event in person, his talk was videotaped in advance and shown to the assembled Masons. This talk focused on the good works the fraternity and its concordant bodies are involved with, specifically the charities related to children and the Shriner Hospitals.

Following the keynote speakers, the remainder of the conference was organized around a limited number of breakout sessions, committee and commission reports. The breakout sessions directed at the Deputy Grand Masters focussed on two topics:

- 1. The importance of communication between the GM and the rest of Grand Lodge; and
- 2. The need to give feedback on the conference to the organizers.

With the exception of the Commission on Information for Recognition, the remainder of the committee and commission reports were directed only at the United States delegates, with other delegates not able to ask questions or discuss the topics. As such, the time spent on these reports was of limited interest or value to Canadian delegates.

Overall, the benefit of the COGMNA has been to meet, connect and discuss with members of other jurisdictions the challenges, opportunities and solutions facing freemasonry. The 2019 conference, unfortunately, provided limited opportunity for meaningful discussion that was relevant to issues facing freemasonry in Alberta. Continual participation by Alberta should be based on a solid, relevant agenda that our jurisdiction could benefit from.

Some Tips on Submitting Photos for Publication.

We at *The Alberta Freemason* love getting your photos for publication. They are one of the very best ways to show the Brethren around the Province what you and your Lodge are doing, the fun you are having, the friends you are making and the difference you make in the communities where you live.

Unfortunately, all too often, the photos we receive are unusable because the subject is too small a part of the picture and we can't blow it up — there are too few pixels to make it clear and sharp. But there are ways to avoid that.

First, don't save your picture for the web or email. That reduces the resolution and/or size to save bytes. Send us the full picture. Then we can crop it or blow it up, if need be.

Second, frame your subject appropriately. If you are shooting a Brother, use portrait mode, get close enough to fill the screen with his head and shoulders. With a group, in landscape mode, move close enough to fill the screen edge to edge with the group. Don't worry if you don't get the feet in the picture, we aren't really interested in what kind of shoes he's wearing.

So bring your camera or phone out when it's a happy occasion. That way, you can "communicate that happiness to others."
