### BRO. KENNETH P. WINDOLFF

Bro. Kenneth P. Windolff was born in St. Paul, Minnesota in 1938. Educated in St. Paul and attended the University of Minnesota, received a B.A. of Mortuary Science Degree. He served as a Fighter Pilot with the U.S. Air Force, has been engaged in funeral service for the last 16 years and since coming to Calgary in 1968 has been continuously employed with Jacques Funeral Home.

Bro. Windolff was raised in Montgomery Lodge No. 258 St. Paul, Minnesota in 1960 and in 1969 affiliated with Perfection Lodge No. 9 in Calgary. He is a member of Scottish Rite and Al Azhar Temple Sabre Patrol as well as serving on the Church Council of Ascension Lutheran Church.

### BRO. PHILIP WILLIAM MAYFIELD, V.W. GRAND CHAPLAIN

Bro. P. W. Mayfield is a native Westerner, born at Williams Lake, B.C., November 7th, 1937. Along with three Brothers Phil was raised on a cattle ranch in the colourful Caribou. Bro. Mayfield graduated with a Bachelor of Arts Degree from the University of B.C. and was ordained a Minister of the United Church in 1965. After Post-Graduate training at Undover Newton College in Boston, Mass. he was appointed Minister at Kitimat Indian Village, B.C.

In 1968 he came to Calgary as Minister of St. Paul's United Church and in 1973 became Chaplain at Hospital District No. 93 which includes Holy Cross and Rockyview Hospitals.

Bro. Mayfield was made a Master Mason in November 1973 and is a member of Perfection Lodge No. 9 where he now fills the office of Senior Deacon. In 1975 he acted as Chaplain of the Masonic Spring Workshop and in June 1976 he was installed as Grand Chaplain of G.R.A. Bro. Mayfield has been invited to speak to Masonic gatherings on many occasions and is in himself a fine example of this years Theme "Walking Tall".

#### RESPONSIBILITY

The Grand Master of Masons in Alberta has chosen "Responsibility" (sometimes defined as duty, or obligation) as his theme for this Masonic Year. This is a very broad term, and encompasses many facets of the way of life which we adopted when we became members of the Order. It would be impossible in this limited space to enlarge upon all the responsibilities with which we have charged ourselves, and many will vary with the individual, but it should suffice to mention some of them and hope that the reader will consider each of them, and pause and contemplate the whole matter of responsibility within our Organization.

There is no doubt that our greatest responsibility is that of benevolence and Charity ("the greatest of these . . .") which has been the subject of many thought-provoking papers in which the true meaning of the word has been expounded and brought home to us in many ways.

The proclamation in connection with Bursary Month says in part. "Let us all accept **responsibility** for the benevolent activities of Grand Lodge and act accordingly." We are all members of that Grand Lodge which several years ago set up this Bursary by a large majority vote, and it is our responsibility to see that it gets the support it so justly warrants. It must be remembered, however, that the Charity towards which we have a responsibility is not only that which is circumscribed by the narrow limits of feeding the hungry, clothing the naked, and soothing the afflicted, but is that which is more noble and extensive, and which regards all men as Brothers.

Responsibility — of Grand Lodge to the Craft in general, and that of the Craft in general to Grand Lodge; to work together with that harmony which will produce a smooth-working, efficient and enriching concept of a better life for mankind.

Responsibility — of a Mason, to the Craft in general, and to his own lodge in particular. "There is no right, without a parallel duty." A member should know the basic structure and functions of the lodge to which he belongs, its local problems, its various projects and activities, and should realize the importance of regular attendance and willingness to participate in lodge work, both within and without the walls of the Temple.

Responsibility — of a sponsor to his candidate. He is introducing his friend to a beautiful system of morality, veiled in allegory and illustrated by symbols, and this friend should not be left to fend for himself until it is very evident that he has grasped the fundamental principles and tenets of Freemasonry, that he has discovered the warm richness of our brotherhood, that he understands the real meaning of Charity, and that the Temple which he is about to build rests upon a firm foundation.

Responsibility — of an investigating committee to the Order and to its own lodge. This committee is charged with the responsibility of determining whether or not the petitioner comes "under the tongue of good report" or not. The committee, along with the sponsors, are the Tylers of the West Gate, and the Lodge is depending upon them for a thorough investigation, which does not consist merely of a short visit with the petitioner, and which among other things recognizes the fact that the absence of anything bad is not necessarily equivalent to the presence of something good. The committee should be completely satisfied that the petitioner does not come with mercenary motives, that he comes of his own free will, and that he is prompted by a favorable opinion of the Order and members of his acquaintance.

Responsibility — of the Master of the Lodge and his officers. There is an obligation here to see that the conduct of the lodge is dignified, efficient and interesting in its social and educational pursuits; and that participation and support towards the activities and objectives of the District and of Grand Lodge are maintained to a high degree.

As mentioned earlier, there are many other responsibilities with which Masons of every level are charged, and it is incumbent upon us all to make ourselves aware of them, and see that they are properly discharged. This, then, would be a giant step towards realizing our ideal, an institution founded on the Fatherhood of God and the Brotherhood of Man!

#### FROM THE GRAND MASTER

In this month's Bulletin, full coverage is given to the Annual Masonic Spring Workshop held at Banff. It has been brought to my attention that there are some attending the workshop in previous years, who have expressed a desire to have a portrayal of selected parts of the Ritual.

I should like, at this time, to clarify the position with regard to this subject. Section 5 of the terms of reference for the Masonic Spring Workshop Planning Committee states:

"The duties of the Planning Committee are to organize and conduct a suitable workshop to instruct Master Masons in the Masonic Way of Life and related subjects, and to stimulate thought on these subjects."

There is no mention made of ritualistic work.

The committee on the Work has ruled many times that ritualistic Work is the responsibility of the W.M. of each Lodge, and any questions he may have, should be directed to the Committee on the Work, in writing, through the Grand Secretary's Office. This Committee is the only one who can make interpretations with regards to the Work. It is absolutely essential that the questions be in writing as many of them require much study and research before an interpretation can be given. The Committee feels, and rightly so, that the Workshop is a gathering of individual Masons not meeting under the jurisdiction of a Lodge or District, and so cannot properly engage in ritualistic work.

It is for the above reasons that ritualistic work will not be portrayed at the Masonic Spring Workshop.
