To celebrate the 275th Anniversary of Grand Lodge, which coincides with the 25th Anniversary of the Grand Master's Installation, the Grand Charity and the Masonic Trust for Girls and Boys have decided to make a donation to four charities active in the field of mentally handicapped adults; an area previously virtually untouched by Masonic

charity.

The sum to be donated in this special year is approximately \$5,200,000. Yes, brethren, a donation of over five million dollars for this one year! The generosity of the members of the United Grand Lodge merits the approbation of Masons throughout the world.

Book Review

Stonehenge — An Ancient Masonic Temple

Russel A. Herner

Published by Macoy Publishing, New York, 1984.

This is an interesting book on the plan, development and building of Stonehenge. The author's thesis is based on the facts and similarities between the position of the monument relative to astronomical observations and both ancient and current Masonic rituals.

The author is widely read on the subject and the book contains an extensive bibliography which, unfortunately, does not give the references in the usual way with the publisher and publication date. This makes it difficult for the reader to run literature searches for himself to read some of the source material.

The author contends that the position of the stones and their orientation to the sun can be related to Masonic ritual. The book title implies that the structure was built as a Masonic Temple. To the reviewer, the book suggests that such a theory is plausible but not proven.

It is obvious that Stonehenge was built for an ancient culture by skilled craftsmen to specifications based on astronomical observations. However, it remains an open question whether that culture was by nature Masonic, or whether operative masonry and therefore, by conjecture, Speculative Masonry developed because of this culture's influence.

The author's development of his thesis to the planning and building of Gothic cathedrals by operative masons and development of the process to the rituals of Speculative Masonry is ingenious. The relevance of the positions of the senior lodge officers in ancient, table and Craft lodges when compared to the positions of the stones at Stonehenge and cathedral floor plans, provides food for thought.

For those interested in ancient monuments and building techniques and their relationship, if any, to Masonry, this book will prove most enjoyable.

What are Scald-Miserable Masons? We thank Bro. John Hopkins of Fort McMurray and R.W. Bro. Clyde Elford of Calgary for their answers.

They point out they are **not** Masons but rather groups of people organized by satirists to ridicule the Masons. In the early part of the 18th century it was common for Masons to assemble in one building and then proceed in procession, in Masonic clothing, to some other place for their Festive Board. The satirists of the day enjoyed forming mock processions and issuing prints ridiculing the Masons.

While many such prints were sold, it was in 1742 that a particular procession was formed with prints published at the same time depicting "The Freemason's Downfall or the Restoration of the Scald-Miserables" and titled A Geometrical View of the Grand Procession of the Scald Miserable Masons, designed as they were drawn up over against Somerset House in the Strand, on the 27th day of April, Anno 1742. (Clavel's Picturesque History, Quoted in Mackey & in Coil) It was this incident that led to the name 'Scald-Miserables.'

Scald is interpreted to mean "beggarly or rascally" according to Shakespeare's use of the word in *King Henry the Fifth*.

Ritualistic Pressure

It is the opinion of your Grand Master that in these times [1923] of rapidly increasing membership, the ritualistic work of the lodge should be separated from the executive; that while the Master should be held to accountability for the character of degree work, yet his energies should be devoted more largely to the development of fraternal relations among his members, educational programs that will instruct yet not disrupt his lodge — in short to do those things that will make his lodge a vital force for service and understanding in the community.

Alberta Masonic Foundation
